### **Supervised Practicum:**

The requirements for admission to the Supervised Practice are as follows:

- 1. Have the approval of the Department Director or Practice Coordinator.
- 2. Maintain an academic concentration index of 2.25
- 3. Have passed the ENTR 4400 and ACCT 1162 courses.
- 4. Submit an official graduation evaluation by the Registrar's Office.

NOTE: The selection of the internship center must be approved by the internship coordinator, who in turn will validate the processing of the documentation required by the Institution.

The Supervised Practice course may be validated to students who request it and demonstrate that they have satisfactorily fulfilled all the requirements established in the General Catalog (current).

#### **Integrated Project:**

For guidance, the student should seek guidance from their academic advisor.

Note: All students must comply with all the requirements in the General Catalog available on the website aguadilla.inter.edu. The official evaluation of the student is conducted by the Registrar's Office after the graduation fee has been paid. Students of the Department of Economic and Administrative Sciences must pass the concentration courses with a minimum grade of "C".
