Elective Courses – 3 credits (check with your academic advisor)

The student may select courses from any program of study, but must meet the requirements of the selected course or take courses without prerequisites.

Retention Requirements

The program requires all students to demonstrate satisfactory academic progress in accordance with the standards set forth in the General Catalog. In addition, the student must maintain a minimum GPA of 2.50 in concentration. The student shall:

1. Earn a minimum concentration average of 2.50 at the college level.
2. Have passed GEEN 1201, 1202, 1203 or 2311, 2312, 2313 with a minimum grade of C.
3. Have passed the HRMT 1200 and HRMT 2100 concentration courses with a minimum grade of B.
4. Have passed with a minimum grade of C the other courses of the concentration and their respective requirements (core or concentration).

Boarding school

The internship (HRMT 4915) may be validated for students who have had satisfactory work experience and request it in writing to the director of the academic department. Such validation shall be subject to; among other requirements, that the student has been working full-time for a minimum period of two consecutive years in a company within the three years immediately preceding the date of application. In addition, the student will pay 50% of the tuition fee for the internship course for which validation is requested. The experience recognized by the University corresponds to the requirement of the degree that the student expects to obtain from the Institution.

Note: The student must maintain a minimum GPA of 2.50 in the concentration. All students must comply with all the requirements of the General Catalog available on the website aguadilla.inter.edu. The official evaluation of the student is conducted by the Registrar's Office after the graduation fee has been paid. Students of the Department of Economic and Administrative Sciences must pass the concentration courses with a minimum grade of "C".
